

ORDINANCE NO 158

AN ORDINANCE APPROPRIATING FUNDS FOR THE PAYMENT OF THE NECESSARY OPERATING EXPENSES OF THE TOWN OF CREEDE AND THE VARIOUS DEPARTMENTS THEREOF FOR THE FISCAL YEAR BEGINNING APRIL 1, 1959, AND FOR OTHER PURPOSES, AND LEVYING TAXES TO PAY SAME.

BE IT ORDAINED by the Board of Trustees of the Town of Creede, Colorado:

Section 1. That there be and is hereby levied upon each dollar of the assessed valuation of all taxable property within the corporate limits of the Town of Creede, Colorado, in this year 1959, for use during the fiscal year beginning April 1, 1959, and Ending March 31, 1960, the following tax:

For the general corporate purpose of said City of Creede (Town).

General Fund 9 mills
Street & Plume Fund 6 mills

Section 2. That out of the revenues of the Town of Creede, Colorado for the fiscal year 1959, from whatever source derived, payable from the General Fund or the City of Creede, for the purpose of defraying the necessary general operating expenses, of the Town and the liabilities thereof; and the objects and purposes for which such appropriations are hereby made, and the amount appropriated for each such object and purpose for said fiscal year, are as follows:

Payable from the General Fund:
Salaries of Town Marshall and others \$1800.00
Salaries of Town Clerk & Treas, Attorney and other employees of the Town 1750.00
For auditing and legal expense 200.00
For Insurance 290.00
For Workmans Compensation 157.00
For membership Colo Municipal League 25.00
Misc'l expenses and other incidentals 1350.00

Section 3.
Payable from the Power Plant Fund:
Salaries Electrician 1500.00
For operation & Maintenance 13500.00
For purchase of Machinery 5500.00
For Misc'l expenses incidental to Power Plant 65.00

Section 4:

Payable from the Water Works Fund:

Salaries Town Clerk and Water Superintendent	\$2000.00
For Maintenance municipal Water Works	450.00
Misc'l Expenses	10.00

Section 5.

Payable from Street and Flume Fund

Salaries Street Superintendent	1400.00
Maintenance, repair and construction of Streets and Alleys	2000.00
For maintenance operation and cleaning of Flume	1500.00

Section 6.

Contingent Fund:

That the Board of Trustees find and determines that a deficiency exists in the Power Plant Fund, and that an emergency exists requiring additional funds to be placed in such Power Plant Fund in addition to revenue from the operation of the municipal power plant. Therefore, the sum of \$2000.00 is hereby transferred from the Contingent Fund to the Power Plant Fund, and the Town Treasurer is hereby authorized and directed to transfer such funds from the credit of the Contingent Fund to the Credit of the Power Plant and to make all proper entries upon the books and records of the City of Creede evidencing such transfer.

That this Ordinance shall become effective on April 1, 1959 from and after its passage.
