

ORDINANCE No. 197

AN ORDINANCE TO REPEAL AND AMEND SECTION 15-1-4 (d) OF ORDINANCE No. 186, CONCERNED WITH PENALTY ASSESSMENT FINES AND THE AMOUNT OF SUCH PENALTY ASSESSMENTS IN THE TOWN OF CREEDE AND TO RAISE SUCH PENALTY ASSESSMENTS.

WHEREAS, it has been determined by the Board of Trustees of Creede, Colorado, a town, that the penalty assessment schedule as set forth in Ordinance No. 186, and as now in effect, does not impose penalty assessment fines that are realistic in terms of the present economy of this town, and;

WHEREAS, the Board of Trustees of Creede, Colorado, has determined that such Penalty Assessment Fines should be increased, as set-forth below, to cover increased costs of law enforcement and to discourage violations of the Model Traffic Code, as adopted by Creede;

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE CITY OF CREEDE, COLORADO, A TOWN IN MINERAL COUNTY, COLORADO :

Section 1. 15-1-4 (d) of Ordinance No. 186 of the Town of Creede, Colorado, is hereby repealed and re-enacted to read as follows:

The violations for which the penalty assessment may be accepted and paid by the violator under the privileges of this section shall be as herein set-forth, subject to any such changes or amendments as may be promulgated by the Municipal Court after the effective date of this Ordinance:

Section 2. The above and foregoing repeal and reenactment of said Section 15-1-4 (d), shall be effective and in full force and effect commencing thirty (30) days after publication by posting in three conspicuous places in Creede, to wit: Tomkins Hardware, Mineral County Courthouse and the United States Post Office.
