

ORDINANCE NO. 207

AN ORDINANCE TO APPROPRIATE SUMS OF MONEY TO THE VARIOUS FUNDS AND SPENDING AGENCIES, IN THE AMOUNTS AND FOR THE PURPOSES AS SET FORTH BELOW, FOR THE CITY OF CREEDE, COLORADO, A TOWN, FOR THE 1977 BUDGET YEAR

WHEREAS, the Board of Trustees of the City of Creede, Colorado, has adopted the annual budget in accordance with the Local Government Budget Law, on the 14th day of November, 1976, and;

WHEREAS, the Board of Trustees of the City of Creede, Colorado, a Town, has made provision therein for revenues in an amount equal to or greater than the total proposed expenditures as set forth in said budget, and

WHEREAS, it is not only required by law, but also necessary to appropriate the revenues provided in the budget to and for the purpose described below, so as not to impair the operations of the City government.
