

ORDINANCE NO. 209

AN ORDINANCE VACATING A PORTION OF ELEVENTH STREET BETWEEN BLOCKS THIRTY-FOUR (34) AND THIRTY-THREE (33), SOUTH CREEDE AND A FIFTEEN (15') FOOT ALLEY INTERSECTING BLOCK THIRTY-FOUR (34), SOUTH CREEDE.

BE IT ORDAINED by the Board of Trustees of the City of Creede, Colorado, a Town;

SECTION 1. PURPOSE AND SCOPE.

The purpose of this Ordinance is to vacate a portion of Eleventh Street in South Creede, Colorado and fifteen (15') foot alley intersecting Block Thirty-four (34) in South Creede, Colorado, which public ways appear on the plat of South Creede.

The purpose of this Ordinance is also to clarify, correct, and amend, in part, Ordinance No. 164, passed on October 7, 1963.

SECTION 2. AUTHORITY.

The Board of Trustees of the City of Creede, Colorado, a Town, hereby declare that it is within the best interests of the City of Creede, Colorado and its residents that the street and alley which is hereinafter described be vacated; that the same was considered at two (2) regular meetings of the Board of Trustees in open session; that under the Statutes of the State of Colorado such vacation may take place, the vacated street and alley thereby being vested in the abutting land owners.

SECTION 3. DECLARATION.

A. The Board of Trustees hereby declare that Eleventh Street between Blocks Thirty-four (34) and Thirty-three (33) in South Creede, Colorado, between the

west boundary of San Luis Avenue and the east boundary of Depot Street, be and the same is hereby vacated and closed and shall no longer be deemed a part of said street. The North half of such vacated street shall revert to the abutting land owners of the lots in Block Thirty-three (33), as required by Statute. The South half of such vacated Street shall revert to the abutting land owners of the lots in Block Thirty-four (34), as required by Statute.


B. The Board of Trustees of the City of Creede, Colorado, hereby declare that the alley being fifteen (15') foot in width intersecting Block Thirty-four (34), South Creede, from the west boundary of Colorado State Highway 149 to the east boundary of Depot Street be and the same is hereby vacated and closed and shall no longer be deemed a part of said alley. The North  $7\frac{1}{2}$  feet of such alley shall revert to the owners of lots in Block Thirty-four (34) abutting the north side of said alley, and the south  $7\frac{1}{2}$  feet of such alley shall revert to the owners of lots in Block Thirty-four (34) abutting the south side of said alley.

SECTION 4. DECLARATION OF USE.

The Board of Trustees of the City of Creede, Colorado, a Town, hereby finds, determines, and certifies that said tracts of land are not and have not been a portion of any water works, ditch, grass works, electric light works, or other public utility, or public building and are not or have not been used or held for park purposes or any other governmental purposes, nor are the same required for any such purposes.
