

AN ORDINANCE CHANGING THE STREET NAMES OF CREEDE AVENUE AND SAN LUIS AVENUE TO MAIN STREET WITHIN THE CORPORATE BOUNDARIES OF THE CITY OF CREEDE, COLORADO, A TOWN

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE CITY OF CREEDE, COLORADO, A TOWN:

Section 1. Short Title: This Ordinance shall be commonly and legally known as the 1990 City of Creede Street Name Ordinance.

Section 2. Purposes: The purpose of this Ordinance is to change the name of that continuous street now known as Creede Avenue and San Luis Avenue to the names North Main Street and South Main Street, across the entire length of such street from the North boundary of the Amethyst Town Site to the south city limits of the City of Creede, Colorado, a Town, including the portion thereof constituting U. S. Highway No. 149.

Section 3. Authority, Effective Date and Recordation: This Ordinance is authorized by the Statutes of the State of Colorado, shall be in full force and effect thirty (30) days after publication and shall be filed for record in the Office of the Clerk and Recorder of Mineral County, Colorado, on or about the 31st day following such publication. The Board of Trustees further finds and declares that no re-plot of the Town of Creede shall be necessary for this Ordinance to be in full force and effect. This Ordinance is intended to have no effect whatever on legal descriptions of properties fronting on the streets herein effected and any legal description utilized in the future which makes reference to North Main Street shall be deemed to automatically make reference to Creede Avenue and any legal description utilized in the future which makes reference to South Main Street shall be deemed to automatically make reference to San Luis Avenue. In addition, any legal description utilized in the future which makes reference to either Creede Avenue or San Luis Avenue, as the case may be, if such property lies South of Wall Street and North of Block 5 in South Creede.

Section 4. Change of Street Names: Creede Avenue, from the point that it intersects the North boundary of the Amethyst Town Site, a point on the north boundary of the south half of the southeast quarter of Section 25, in Township 42 North of Range 1 West, NMPM, Mineral County, Colorado, southerly to its intersection with Wall Street, on the South boundary of the Amethyst Town Site, be and the same shall be known and described as and from and after this date shall be designated as "North Main Street". It is impossible to determine from the existing plat of the Town of Creede, the precise point at which Creede Avenue became San Luis Avenue prior to the effective date of this Ordinance. Such point is either at the intersection of Wall Street or at a point West of Block 5, South Creede. Accordingly, that continuous street heretofore known as Creede Avenue and San Luis Avenue, from its point of intersection with Wall Street on the South boundary of the Amethyst Town Site (and the North boundary of South Creede), southerly to the point where such Street exits the South corporate limits of the Town of Creede, a point near the Southeast corner of Block 52, South Creede, all as platted, be and the same shall be known and described as and from and after this date shall be designated as "South Main Street". Such designation shall be applicable to all portions of such street, including that portion of such street which is also designated as Colorado Highway #149, from Seventh Street southerly to the point that such highway exits the corporate limits of the Town of Creede on the south boundary of such Town limits, all as platted.


Section 5. This Ordinance shall be in full force and effect thirty (30) days after publication.
