

ORDINANCE NO. 316

AN ORDINANCE TO REPEAL ORDINANCE NO. 225 CONCERNING SEWER RATES AND TO RAISE SAID SEWER RATES IN THE CITY OF CREEDE

WHEREAS, it has been found and deemed necessary to increase rates for furnishing of sewer services in the City of Creede, a Colorado Town, to cover increased maintenance, services and similar costs:

BE IT ORDAINED by the Board of Trustees of the City of Creede, A Colorado Town, in Mineral County, Colorado;

SECTION I: Ordinance No. 225 be and the same is hereby repealed and from and after the effective date of this ordinance the effective sewer rates for the City of Creede shall be in accordance with this Ordinance.

SECTION II: SEWER RATES: There is hereby levied and charged on each lot, parcel of land and premises served by or having sewer connections with the sewer system of the Town or otherwise discharging sewage, industrial wastes, water or other liquids either directly or indirectly into the Town sewer system a sewer service charge or rental which shall be payable in an amount as follows:

All Single Family Residences	\$9.24
Business	9.24
Hotels/Motels/B&B (per unit)	6.67
Multi-Unit (per unit)	6.67
Trailer	6.67
Schools on single connection	23.10
Restaurants (with less than 39 seating capacity)	16.17
Restaurants (with more than 40 seating capacity)	23.63
Bars and Recreation	16.17
Industrial (Dry) and Car wash on single connection	26.57
Gas Stations w/o wash rack and Laundries	23.10
Manufacturing or Industrial plant which discharges water into the sewer on a single sewer connection by special agreement with Town Board – minimum charge of \$46.20.	

SECTION III: The above foregoing repeal of Ordinance No. 225 concerning sewer rates shall be effective on or after the 1<sup>st</sup> day of January, 2001.

SECTION IV. This Ordinance shall be codified into the Municipal Code. Any changes in numbering of paragraphs, sections or subparagraphs shall not change the validity of any part of the Ordinance. The word "Ordinance" may be changed to "Title", "Section", "Subsection", or "Code" as necessary

First reading of this ordinance, introduced, read in full, passed, and approved upon Motion, Seconded and unanimous vote at a regular meeting of the Board of Trustees of the City of Creede, A Colorado Town held on the 6<sup>th</sup> day of November, 2000.
