ORDINANCE NO. 325

AN ORDINANCE TO REPEAL ORDINANCE NO. 315 and 316 CONCERNING WATER AND SEWER RATES IN THE TOWN OF CREEDE

WHEREAS, it has been found and deemed necessary to increase rates for furnishing of water in the City of Creede to cover the increased costs of maintenance, service and similar costs of the water system;

BE IT ORDAINED by the Board of Trustees of the city of Creede, A Colorado Town, in Mineral County, Colorado;

SECTION I: Ordinance No. 315 and 316 be and the same are hereby repealed, which ordinances were established for the sole purpose of establishing water rates and sewer rates as of the date of such ordinances and which rates are no longer feasible.

SECTION II: WATER RATES: All water sold by the City of Creede shall be sold at the following monthly rates:

All Single Family Residences	22.08
Business	29.64
Hotels	59.28
Multi-Unit (Per unit)	22.08
Trailer	22.08
Industrial	171.01
Sr. Resident	22.08
Restaurants	59.28
Churches	22.08

Water rates for persons, entities or buildings not specifically covered herein shall be set by the Board of Trustees of the City of Creede, A Colorado Town in conformity with the intent of the foregoing rates.

SECTION III: SEWER RATES: All sewer service sold by the City of Creede shall be sold at the following monthly rates:

All Single Family Residences	9.71
Business	9.71
Hotels/Motels/B&B (per unit)	7.01
Multi-Unit (per unit)	7.01
Trailer	7.01
Schools on single connection	24.26
Restaurants (with less than 39 seating capacity)	16.98
Restaurants (with more than 40 seating capacity)	24.82
Bars and Recreation	16.98
Industrial (Dry) and Car wash on single connection	27.90
Gas Stations w/o wash rack and Laundries	24.26

Manufacturing or Industrial plants which discharges water into the sewer on a single sewer connection by special agreement with Town Board – minimum charge of \$48.51.

SECTION IV: DRAINAGE FEE: Each customer for water and/or sewer service in the City of Creede shall be charged a \$1.00 per month drainage fee per tap.

SECTION V: The above and foregoing repeal of Ordinance No. 315 and 316 concerning water rates and sewer rates and the addition of a monthly drainage fee shall be effective on or after the day of, 2002.
SECTION VI. This Ordinance shall be codified into the Municipal Code. Any changes in numbering of paragraphs, sections or subparagraphs shall not change the validity of any part of the Ordinance. The word "Ordinance" may be changed to "Title", "Section", "Subsection", or "Code" as necessary.
