I agree to indemnify and to hold harmless, the City of Creede, its officers, employees, and agents from any loss, liability, damage, cost, or expense which they may incur as the result of my death or any injury or property damage that I may sustain while participating in any activity at this or any other Creede Parks and Recreation facility.
